### 10. Board Business (old and new)

Motion- For Gentry Academy to withdraw from the free school lunch program.

Made by: Nikki Foley Seconded by: Joe Norlin

#### Discussion

-Jennifer Kurth presented the family feedback survey results, overall families were not pleased with the program last year, around 160 lunches per day out of the 300+ students, 80% said no or minor impact if we withdraw, 0.8% (2 students) impact would be looking at different schools, comments included concern about food quality/portion/not healthy options, shared parent questions/ideas/etc.

- -Points of discussion included:
  - What is the 0.8%'s why?
    - o Didn't say, but could be financial
  - Is the food good?
    - Lunch supervisors hear negative feedback every day from students, a la carte options are very slim and kids are missing those extra options
  - What are the community table and a la carte options that are available now?

- o If students don't want something that they have to take for their lunch they put it on the community table and anyone can take it. A la carte is very minimal.
- What would the deficit be with the new program? Can the foundation cover families that can't afford lunch?
  - Supplementing some funding would hopefully work and parents were asked about donating and some said they would, goal is to not have that deficit if moving programs
- How does withdrawing from the free program affect staff?
  - Being a part of the program requires an extensive amount of reporting to the state and it would be significantly less work for staff to not be in the program
- Can we supplement with other things (more a la carte items) and keep the free program?
  - o All foods that are being sold in the lunch room recipes have to be approved by the state
  - The guidelines the state has are difficult to follow
  - We tried other items besides nautical bowls and it's hard to get them accepted

JS & AZ- bringing cold lunch and getting a hot lunch to eat more or give to other students JS- worried about the \$50-60,000 deficit and quality

- Did we look at different free lunch program vendors?
  - We didn't this year, but we had in the past
  - Not that many differences because of state guidelines
  - Current vendor has tried to accommodate with changing recipes
- If we get a yea vote what are the next steps?
  - We can get out of our contract if not participating in the free program
  - Look at the 3 bids we have and make a choice from there
- What are the bids?
  - o John Smith shared a summary of the bids (Euphoria Foods, Done Right Foods, Tahar)
- Will the \$50-\$60,000 deficit go away if using a new program?
  - After bids shared, of 3 issues going with a new vendor would solve 2 hopefully and then possibly solve the 3rd (deficit) if going with Tahar
- Will parents be concerned about a cost with this starting in September?
  - It was stated in survey and has been an on-going conversation since to June, so there shouldn't be concern
- If we choose to move to away from free program this year can we go back the following year?
  - Yes you can enter back in
- How many students before free program were free and reduced?
  - o 0, but our student body has changed
- Do you think that families that qualify for reduced lunch might put us back into a deficit?
  - o I think there is a way that we could supplement maybe like reduced fee and that would help
- From a marketing perspective is it better to say that we have the free program or a school that provides greater options/fuel for food?
  - A family shared that the great food years ago was a selling/retention point for them
